further to amend the Azad Jammu and Kashmir Legislative Assembly Act Deputy Speaker (Salary, Allowances and Privileges) Act, 1986

Whereas, it is expedient further to amend the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker (Salary, Allowances and Privileges) Act, 1986 (Act VIII of 1986), in the manner hereinafter appearing:

It is hereby enacted as follows:-

- Short title and Commencement.- (1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker 1. (Salary, Allowances and Privileges) (Amendment) Act, 2019.
  - It shall come into force at once and shall be deemed to have taken effect from 1st day of June, 2017.
- Amendment of Section 3-A, (Act VIII of 1986).- In the Azad Jammu and Kashmir Legislative Assembly Deputy Speaker (Salary, Allowances 2. and Privileges) Act, 1986 (Act VIII of 1986), hereinafter referred to as the said Act, in Section 3-A, for the words "twenty five thousand", the words "twenty thousand" shall be substituted.
- Amendment of Section 5, (Act VIII of 1986).- In the said Act, in Section 5, for the words "twenty thousand", the words "twenty five 3. thousand" shall be substituted.
- Amendment of Section, 6 (Act VIII of 1986).- In the said Act, in 4. Section 6, after the words "throughout his term of office" the words "and for a period of fifteen days immediately thereafter" shall inserted.
