Act

to provide a law for terms and conditions of the Members of the Azad Jammu and Kashmir Election Commission

Whereas, it is expedient to provide a law for terms and conditions of members of the Azad Jammu and Kashmir Election Commission for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title, Extent and Commencement.**- (1) This Act may be called the Azad Jammu and Kashmir Members of the Election Commission (Terms and Conditions) Act, 2019.
(2) It shall be applicable to the Members of the Election Commission.
(3) It shall come into force at once and shall be deemed to have been taken effect from the 2nd October, 2018.
2. **Definitions.**- In this Act, unless there is anything repugnant in the subject or context,-
 - (a) "Government" means the Azad Government of the State of Jammu and Kashmir;
 - (b) "President" means the President of Azad Jammu and Kashmir; and

(c) "Members" means a Member of the Election Commission, appointed under sub-Article (6) of Article 50 of the Azad Jammu and Kashmir Interim Constitution, 1974.

b. **Pay, Allowances, etc.**- (1) A Member shall be entitled for the following pay, allowances and other privileges:-

i)	Remuneration	Rs. 300,000/-
ii)	House Rent	Rs. 50,000/-
iii)	Transport	1600cc car
iv)	Diesel/ Petrol	As admissible to Secretary to the Government
v)	Telephone	-do-
vi)	DA/TA	-do-

(2) A Member appointed shall be deemed to have accepted the above terms and conditions and shall not be eligible for any enhancement or different terms and conditions.

(3) These terms and conditions shall be applicable from the date of appointment.

4. **Age.**- No person shall be appointed as a member who is more than sixty five years of age:

Provided that this condition shall not be applicable to a Member appointed prior to enforcement of this Act.
