



No. LD/Legis.-Act/01-15/2022. The following Act, passed by the Azad Jammu and Kashmir Legislative Assembly on 22nd day of February, 2022 and received the assent of the President on the 23rd day of February, 2022, is hereby published for general information.

[Act I of 2022]

to repeal the Azad Jammu and Kashmir Regulation of the Services of Certain Categories of Contractual, Ad-hoc or Temporary Government Employment (Terms and Conditions) Act, 2021

Whereas, it is expedient to repeal the Azad Jammu and Kashmir Regulation of the Services of Certain Categories of Contractual, Ad-hoc or Temporary Government Employment (Terms and Conditions) Act, 2021 (Act XI of 2021) in the manner hereinafter appearing;

And whereas, the Azad Jammu and Kashmir Interim Constitution, 1974 guarantees fundamental rights to all State Subjects and any law which takes away or abridge such rights is void abinitio;

And whereas, the Azad Jammu and Kashmir Interim Constitution, 1974 provides inter alia equality, equal protection of law, promotion of social justice, freedom of profession and safeguard against discrimination in service to all State Subjects;

It is hereby enacted as follows:-


1. **Short title and commencement.**- (1) This Act may be called the Azad Jammu and Kashmir Regulation of the Services of Certain Categories of Contractual, Ad-hoc or Temporary Government Employment (Terms and Conditions) (Repeal) Act, 2022.

(2) It shall come into force at once and shall be deemed to have taken effect since 02.06.2021.

2. **Repeal of Act XI of 2021.**- (1) The Azad Jammu and Kashmir Regulation of the Services of Certain Categories of Contractual, Ad-hoc or Temporary Government Employment (Terms and Conditions) Act, 2021 (Act XI of 2021), is hereby repealed from the date of its enforcement.

(2) Notwithstanding anything contained in the Azad Jammu and Kashmir Regulation of the Services of Certain Categories of Contractual, Ad-hoc or Temporary Government Employment (Terms and Conditions) Act, 2021, all appointments made, proceeding initiated, notifications issued or any action taken under the repealed Act shall rescinded and have no legal effect.

3. **Repeal.**- The Azad Jammu and Kashmir Regulation of the Services of Certain Categories of Contractual, Ad-hoc or Temporary Government Employment (Terms and Conditions) (Repeal) Ordinance, 2021 (Ordinance X of 2021), is hereby repealed.
