to repeal the Federal Public Service Commission Ordinance, 1977

Whereas, it is expedient to repeal the Federal Public Service Commission
Ordinance, 1977 (XXV of 1977), adopted vide Azad Jammu and Kashmir
Council Public Service Commission (Adaptation and Validation) Act, 2009
(Act I of 2009), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- Short title, Extent and Commencement. (1) This Act may be called the Federal Public Service Commission (Repeal) Act, 2019.
 - (2) It shall come into force at once.
- 2. Repeal of Federal Public Service Commission Ordinance, 1977 (XXV of 1977).- The Federal Public Service Commission Ordinance, 1977 (XXV of 1977), adopted vide Azad Jammu and Kashmir Council Public Service Commission (Adaptation and Validation) Act, 2009 (Act I of 2009) is hereby repealed.
- 3. Application of Azad Jammu and Kashmir Public Service Commission, Act, 1986. Appointments in B-16 and above in departments, secretariat or any statutory body or institution or organizations, which have been transferred or shifted to Azad Government of the State of Jammu and Kashmir under the Azad Jammu and Kashmir Interim Constitution (Thirteenth Amendment) Act, 2018 shall be made on the recommendations of Azad Jammu and Kashmir Public Service Commission constituted under Article 48 of the Azad Jammu and Kashmir Interim Constitution, 1974.

4. <u>Savings and Validation</u>.- All actions taken, recommendations made, power exercised, etc., under the repealed Act shall be deemed to have been validly taken, made, exercised under the repealed Act.
