## [Act XIV of 2019]

to provide a law for terms and conditions of the Members of the Azad Jammu and Kashmir Election Commission

Whereas, it is expedient to provide a law for terms and conditions of members of the Azad Jammu and Kashmir Election Commission for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- Short title, Extent and Commencement. (1) This Act may be called the Azad Jammu and Kashmir Members of the Election Commission (Terms and Conditions) Act, 2019.
  - (2) It shall be applicable to the Members of the Election Commission.
  - (3) It shall come into force at once and shall be deemed to have been taken effect from the 2<sup>nd</sup> October, 2018.
- 2. <u>Definitions</u>.- In this Act, unless there is anything repugnant in the subject or context,-
  - (a) "Government" means the Azad Government of the State of Jammu and Kashmir;
  - (b) "President" means the President of Azad Jammu and Kashmir; and

- (c) "Members" means a Member of the Election Commission, appointed under sub-Article (6) of Article 50 of the Azad Jammu and Kashmir Interim Constitution, 1974.
- Pay, Allowances, etc.- (1) A Member shall be entitled for the following pay, allowances and other privileges:-

- (2) A Member appointed shall be deemed to have accepted the above terms and conditions and shall not be eligible for any enhancement or different terms and conditions.
  - (3) These terms and conditions shall be applicable from the date of appointment.
- 4. Age.- No person shall be appointed as a member who is more than sixty five years of age:

Provided that this condition shall not be applicable to a Member appointed prior to enforcement of this Act.
