No. LD/Legis.-Act/192-202/2023. The following Act, passed by the Azad Jammu and Kashmir Legislative Assembly on 30<sup>th</sup> day of November, 2023 and received the assent of the President on the 13<sup>th</sup> day of December, 2023, is hereby published for general information.

further to amend the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975

**Whereas,** it is expedient further to amend the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975 (Act XVIII of 1975);

It is hereby enacted as follows:-

1. **Short title and Commencement.**- (1) This Act may be called the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) (Amendment) Act, 2023.

(2) It shall come into force at once and be deemed to have taken effect since 02.11.2023.

2. **Amendment of Section 7-A, Act XVIII of 1975.**-

In the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975 (Act XVIII of 1975), hereafter referred to as the said Act, in Section 7-A, for the words and expression "official car, services of a clerk (B-11), one driver, one gun man", the words and figures "official jeep up to 3000 cc, services of an Assistant (B-16), one driver and police guard consisting of one upper sub-ordinate and four constables" shall be substituted.

3. **Amendment of Section 8-A, Act XVIII of 1975.**-

In the said Act, Section 8-A shall be re-numbered

as sub-section (1) and thereafter following new sub-section (2) shall be added:

"(2) Any person who has been the elected Prime Minister of AJ&K under AJ&K Interim Constitution 1974, shall be entitled free access to government guest houses, rest houses and circuit houses in the country."
