No. LD/Legis.-Act/237-47/2023. The following Act, passed by the Azad Jammu and Kashmir Legislative Assembly on 30<sup>th</sup> day of November, 2023 and received the assent of the President on the 13<sup>th</sup> day of December, 2023, is hereby published for general information.

further to amend the Prime Minister Inspection and Implementation Commission Act, 2002

**Whereas** it is expedient further to amend the Prime Minister Inspection and Implementation Commission Act, 2002 (Act VI of 2002);

It is hereby enacted as follows:-

**1. Short title, extent and commencement.- (1)**

This Act may be called the Prime Minister Inspection and Implementation Commission (Amendment) Act, 2023.

(2) It shall extend to the whole of Azad Jammu and Kashmir.

(3) It shall come into force at once and shall be deemed to have taken effect from 06.03.2023.

**2. Amendment of Section 3 (Act VI of 2002).-**

In the Prime Minister Inspection and Implementation Commission Act, 2002 (Act VI of 2002), hereinafter referred to as the said Act, in Section 3, in sub-section (2), for the word "Government" the words "Prime Minister" shall be substituted.

**3. Amendment of Section 4 (Act VI of 2002).-**

In the said Act, in Section 4, following amendments shall be made:-

- (i) in sub-section (1), for the word "Government", wherever occurring, the words "Prime Minister" shall be substituted.

(ii) after sub-section (1), following new sub-section (1-a) shall be added:-

“(1-a) In case, Chairman is appointed from amongst the Members of Azad Jammu and Kashmir Legislative Assembly, he shall be entitled to the same perks and privileges as are admissible to a Minister to the Government:

Provided that if the Chairman is appointed from persons other than Secretaries to the Government or Member of Azad Jammu and Kashmir Legislative Assembly, his perks and privileges shall be determined by the Prime Minister.”

**4. Amendment of Section 5 (Act VI of 2002).**-

In the said Act, in Section 5, for the word “Government”, wherever occurring, the words “Prime Minister” shall be substituted.
